1	<ul style="list-style-type: none"> Given that funding is on reimbursement basis, assuming after Front End Engineering Design (FEED) study is completed, the team decides not to proceed with the EPC/installation of the demo (if FEED results show that regulatory hurdles cannot be overcome or costs become prohibitive due to challenges that arise during FEED stage), will the RFP team clawback the funds that were already disbursed for FEED if the project is aborted subsequently? 	As stipulated under para 4.2 of the Information Letter, a project milestone-based funding scheme will be applied for awarded projects under the JIRFP, with fund disbursements to be made only upon the completion of each project milestone by the Awardee in accordance with the agreed timeline and requirements, to the satisfaction of EMA and JTC. Disbursed funds will not be clawed back.

	<ul style="list-style-type: none"> In reference to Corrigendum 2 on "Post Project Arrangements", we have noted that Item 26 IP Arrangements indicated "JTC and the awardee will co-own foreground IP developed through the project." <p>If JTC co-owns the IP, and should the awardee want to transfer, or license IP, what are the restrictions, rights and/or obligations for the awardee?</p>	<p>The Collaborator shall be entitled, by itself or its agents, to deal with and dispose of the Foreground IP and its title, rights and interests therein (including assignment of, granting of licences, sub-licences to third parties and commercialisation of the Foreground IP) subject to the following terms and conditions:</p> <ul style="list-style-type: none"> (a) prior written consent of JTC (such consent not to be unreasonably withheld) must be obtained; (b) JTC shall be entitled to a right of first refusal in the event the Collaborator intends to assign the Foreground IP to a third party.
